The score will be given by <u>references</u> submitted by <u>Bidders</u> in the tender documents – List of References, Appendix M1-M2 and M3. Accordingly, technical forms shall be sent to references for completion regarding service experience and/or actual service provision – Appendix L. A summary report will be presented to the technical committee forum for final scoring and approval. 2.1. Opinions must be given by at least 3 references. 2.2. The <u>summary</u> report shall be an average of the reports submitted. 2.3.
